Councilman Greer said he agrees the location is good; however, he has had discussion with people who work at the courthouse express their concern with the age of the building and possible mold issues from water damage, etc. Councilman Greer said he is only thinking about the overall health/wellness of the courthouse employees and thinks that should be considered when making the decision. Discussion took place with City Manager Tim Young stating the resolution in question asks for the County to conduct detailed study on the implications of a move such as this [including the loss of businesses in the area of downtown McDonough] and to weigh this as a factor in making a decision to move rather to construct better buildings nearby that the county or the city owns.
