4. Ordinance for the purpose to rezone approximately 3.0 acres located in Land Lot 186 of the 2nd District; to amend Section 17.04.137 entitled "Historic District Overlay"; to amend the Official Zoning Map to extend the Historic Preservation District Overlay (HPDO) boundary to incorporate additional properties along the west side of Cleveland Street, to update ownership and district information; and for other purposes –

Mayor Price called on Mr. Michael Powell to step forward with his comments.

Mr. Michael Powell; Pastor of South Point Fellowship, stepped forward to comment. Mr. Powell is requesting Council postpone this item. Mr. Powell said he represents 400 of the City's voting constituents and after much research do not see the benefit of this rezoning. Discussion took place and Mr. Powell assured Council he is not opposed to the Historic District; however, he would like more time to review so that he and others understand the benefit if any. Mr. Powell asked Council to postpone this item so that hopefully after more research he will be in favor of instead of opposed.

Mayor Price asked for a motion to postpone until January 6, 2020. Councilman Greer made the motion with second by Councilman Taylor and further discussion took place.

Councilman Greer asked Mrs. Ogg if there is a time limit for submitting. Mrs. Ogg said she is not aware of a time limit.

Councilman Boone made a comment we advertised this accordingly and asked Mr. Powell why he is just now coming with the request to postpone. Mr. Powell said he met with the Historic Preservation Council in August; however, would like to meet again to clarify questions he has. Mr. Powell said he has not had time to meet since the last Council meeting and as a Church leader he is trying to gather viewpoints from everyone.

Councilman Boone asked if there were questions that could be answered tonight. Mr. Powell replied since the Church does not pay taxes; he is trying to understand the benefit this would be to them. Mr. Young said we would not have to advertise a second time because it would not be outside the time frame required. Attorney Andy Welch said nothing legally would undermine Council from postponing to January and no reason to advertise again.

Councilman Greer asked if 30-days would be enough time. Mr. Powell and Attorney Andy Welch agreed 30-days would be enough time.

CITY MANAGER'S COMMENTS -

7. FY 2020 Operating and Capital Improvements Budget Hearing schedule and update

City Manager Tim Young stepped forward with an update on capital projects including signalized intersections, providing turning lanes, paving existing streets and expanding existing ones. We will be expediting the new Industrial Interchange near Bethlehem Road and I-75, adding a signal at Market Place and Highway 42, and an intersection at Bill Gardner and Highway 42 and Bill Gardner and I-75. We will be debuting one new website and two websites rehashed. We will add a new Tanger Park that will include a walking trail, dog park, and pavilion. Further, Mr. Young reviewed and gave an update for 2020, the General Fund Budget is at \$8,301,570 and includes many of the projects discussed above. For our enterprise funds the total revenues and expenditures are \$7,919,940 and in all the proposed FY 2020 combined budget is \$16,221,510. Our proposed formal budget hearings are scheduled for November 18, 2019 and December 2, 2019 prior to adoption for installation in 2020.

8. Update of Operations and Capital Items (Tim Young and Bert Foster, Assistant City Manager)

Mr. Young continued with an update several of us had a meeting with GDOT last Monday, October 28, 2019 and received positive comments and overall a very positive meeting. We are hoping to receive assistance from GDOT on some of the projects that are in line. We are trying to move forward with the MMIP project and items that were discussed at the retreat. Mr. Young said the Community Development office is now open and operational.

Councilman Greer asked if TIP was discussed at the GDOT meeting and Mr. Young replied yes and discussion took place. Mr. Young said GDOT is working with ARC staff and they seem very supportive of it.

Councilman Boone asked if there was any mention of the SPLOST money from the County that they have not released. Attorney Andy Welch clarified Councilman Boones question and confirmed Councilman Boone means the \$5.5 million dollars the voters approved; the money that has not been spent from both State and Federal Government. Mr. Young said the County has declined spending anymore money and only spent money on the feasibility study and IJR; therefore, this responsibility to move the project forward is having to fall back on the City of Locust Grove. Mr. Young said there was no discussion about the SPLOST V money at the meeting and discussion took place. Nothing further.
