<u>NEW BUSINESS/ACTION ITEMS</u> –

9. Ordinance to amend the Police Standard Operating Procedures (SOP) for revising Section P-027 - Taser –

Chief Austin stepped forward and led discussion this is a revision because we upgraded to the Taser 7 version. This version is safer, more powerful, and is linked to the body cameras. We sent three officers for their training certification, and all our officers will have to complete the TASER training which will be led by our three certified employees.

Councilman Greer referenced letter "H" regarding medical assistance and asked, "If the subject should be tased who will remove the darts"? Lieutenant DeMuth stepped forward and said we [certified staff] will train our officers to remove; however, the subject would be transported to the hospital for removal of any from the chest, groin, or other areas specified in the policy that we are not authorized to remove. Councilman Greer asked if (CEW) conducted energy weapon was formally known as conducted electric weapon? Chief Austin said yes but has since changed to "energy." Discussion took place about the strength and operation of the Taser and nothing further.

Mayor Price asked for a motion. Councilman Greer made the motion to approve the request by approving ordinance #22-05-031

Councilman Breedlove asked for an update on concluding the dedication of Chase Maddox Park. Chief Austin said he spoke with the family today and the family said they will accommodate their schedule according to a date/time set by the city. Chief Austin suggested May 19th or 20th or May 26th or 27th. Council agreed on May 26th, 2022, at 11:00am. Further, Chief Austin said Chase's vehicle has been repaired [for display purposes only] and in process of installing a memory wrap on the hood. We are hoping the vehicle will be complete so that we can have his vehicle present at the dedication.

10. Resolution to appoint Bart Hammock to the Henry City-County Transportation Advisory Group –

Assistant City Manager Bert Foster stepped forward. Mr. Foster said this will consist of a tenmember panel for the purpose of defining transportation needs in Henry City/County. This appointment will be a two-year term and may be renewed for an unlimited number of terms.

Mayor Price asked for a motion. Councilman Greer made the motion to approve the request by approving resolution #22-05-032

CITY MANAGER'S COMMENTS –

Mr. Young stepped forward and said HB 1399 pertaining to Homestead Exemption for Ad Valorem property tax was signed by the Governor, and we are waiting on the certified copy to forward to the election's supervisor, Ameika Pitts. We will be the first city to have their own exemption on property tax. We are in the process of assessing fees for storm water and streetlights for various subdivisions as part of the streetlight district. Mr. Young said we released bids for resurfacing streets and getting ready to release the bid for Bill Gardner Parkway. We will have a meeting with the county tomorrow for discussion of suggested transportation improvements to be in the CTP update. Nothing further.

Councilman Boone asked about the status for the sign at city hall. Mr. Young said it was ordered and waiting on the electronic portion to arrive from (backorder).

Councilman Greer said he and Colleen collaborated about having a community event on the front lawn at City Hall. We discussed briefly at the last council meeting and Councilman Greer said the event will be Friday May 13, 2022, from 6-9pm. Mr. Young said the Events Committee voted to pay for the DJ and porta potties.

Councilman Boone asked who made the decision to approve the event location for the front lawn? Councilman Greer said the Events Committee agreed on the location. Councilman Boone said the Events Committed did not approve the front lawn as the location. Councilman Greer said a couple of years ago we voted on the Master Plan for this property to be utilized for community gatherings. Councilman Greer said Council has never voted on events (Easter Egg Hunt, Locust Grove Day, or any other city-wide event) and said these are all events to bring the community together. Councilman Boone said he agrees with the event; however, does not agree with having on the front lawn. Councilman Boone said we specifically purchased property now known as Claude Gray Park and spent lots of money on the pavilion and stage to accommodate events city wide. Councilman Greer said the problem with having events at Claude Gray Park is visibility.

Councilman Williams said he agrees with the lack of visibility at Claude Gray Park and suggested having the event on the front lawn to generate activity [initially] and eventually transition the event to Claude Gray Park.

Mayor Price said the land at Claude Gray Park was purchased for the purpose of having events. Parking was an issue with having on the front lawn.

Councilman Breedlove said he prefers this event to be on the front lawn and any other events as well.

Councilman Shearouse asked if there is a regulation specifying that we cannot have events on the front lawn. Mr. Young said no, we moved everything to Claude Gray because of the lack of parking and exhibitor space. Staff is supportive of the event; however, keep in mind the front lawn cannot handle the capacity of large events should this event grow that large.

Councilman Taylor suggested trying this event on the front lawn and making changes if need be.

Councilman Williams said he agrees with trying the event on the front lawn. This does not have to be permanent and can always change location in future if needed.

Councilman Shearouse said he appreciates the initiative by Colleen and Councilman Greer to coordinate an event like this.

Councilman Boone said he will be sure to plan events such as (BBQ cookout, car show, etc.) on the front lawn in the future and discussion took place.

Mayor Price said this is a city event not a private function.

Attorney Andy Welch said an event can be held on city property as longs as city sponsored. A private function would not be permitted. Mr. Welch said Council needs to agree or not on approving the event to be held on the front lawn. Councilman Boone asked who is paying for porta potties? Mr. Young said it would be paid out of building and grounds (expenditure) [due to conflicts with cleaning personnel at public safety].

Mayor Price said an agreement needs to be reached and voted for event to take place on the front lawn at City Hall.

Councilman Breedlove made the motion to approve the event proposed by the Events Committee to be held on Friday May 13, 2022, on the front lawn at City Hall.

Councilman Shearouse said if Councilman Greer did not help with organizing this event someone else would have had to present to council, correct? Mr. Young said if the event were a private, non-profit event the "applicant" would have to submit a special event request and come before council for approval not to the Events Committee. The Events Committee puts on events on behalf of the city which is why we must differentiate city events and other events regarding the use of the front lawn.
