5. Ordinance for annexation of 6.29 +/- acres located on Highway 42 and Canup Road Parcel ID: (147-01003009 and 163-01001001) in LL 130 of the 2^{nd} district (Motion Required) -

6. Ordinance for rezoning of 6.29 +/- acres located on Highway 42 and Canup Road Parcel IDs: (147-01003009 and 163-01001001) in LL 130 of the 2nd district from M-1 (light-manufacturing) unincorporated Henry County to M-1 (light-manufacturing) City of Locust Grove –

Daunté said the ordinance presented is as staff recommends; however, can add additional language as the council suggested on the use for truck parking.

Mayor Price asked for a motion. Councilman Shearouse made the motion and seconded by Councilman Boone. Councilman Williams said he would like to include the additional language on the use of truck parking.

Attorney Andy Welch said the current motion is as staff recommends and said the council can make a motion to amend the motion to add restrictions.

Mayor Price asked for a motion. Councilman Shearouse made the motion to amend the original motion to include staff recommended language and restrictions on the use of truck parking by approving ordinance #23-10-083.

Daunté read aloud the condition as follows that will be attached as Exhibit D:

1. The subject property shall be entitled to all principal uses allowed in the M-1 (light-manufacturing) zoning district, except truck parking.

7. Conditional Use request to allow gravel-surfaced truck/tractor-trailer parking on Walker Crossing, Parcel ID: 147-01003011 –

Mayor Price asked for a motion. Councilman Boone made the motion to table the request with conditions. Andy asked Councilman Boone if he is requesting to table or add conditions and discussion took place. Councilman Boone said he is motioning to table the request. Councilman Shearouse seconded the motion.

Daunté said Councilman Boone expressed concern about the railroad crossings not having any crossing gates and Daunté provided a copy of the correspondence (attachment to minutes) between the attorney and Councilman Boone. Daunté read aloud the two conditions that were suggested and said the conditions would code the permits until the requirements have been met. The time it would take for them to meet the requirements may not match up with the motion to table.

Councilman Boone said there are no gates on the crossing, and we had to close the crossing because tractor-trailers kept getting stuck. Mayor Price asked if a stipulation should be added or deny the request all together?

Andy said the motion to table will allow the applicant to make improvements and report to the council from GDOT and NS before the council decides. The motion would hold the application in place and would allow the application to remain viable. Councilman Williams asked how long is the "tabled" motion effective? Andy said normally the council has three months to decide. Bert said he has been in contact with the owner, and they have inquired as to what needs to be done. Bert said a right-of-way dedication would be required and may or may not add to the process of the three months. Andy said the city doesn't have to accept any road as public right-of-way because the liability would become the city. There are legitimate public safety concerns and the motion in place would allow the property owners to resolve the issues.

Councilman Shearouse asked is it better to postpone or table. Andy said tabling puts the request on hold until information is available, and postponing requires a set date for a decision to be made.

Councilman Boone said it seems the owner is wanting the city to make the improvements. Andy said not necessarily because they are trying to satisfy that of what GDOT suggests.

Daunté asked if the goal is to make sure all the upgrades are done at the property owner's expense. Boone said yes. Daunté said condition one accomplishes that. Andy said Daunté is correct and if the council approves the conditional use, the council would have made a land use decision that sets precedence for the surrounding properties.

Mayor Price said any surrounding property cannot be sold or developed until the crossing is improved. Andy said that is correct. Daunté said if the request is denied, the applicant would have six months to re-apply. Andy reminded the council that a moratorium is in place and the applicant cannot re-apply for one-year.

Alex McCart, representative for the applicant, stepped forward to comment. Alex said there are other businesses who use the crossing as well. Alex said they would like to move forward with the conditional use approval which would allow them to get with GDOT and NS. Further, Alex said the property owner in question is not his client. Bert said David Whitaker is the owner and he owns Southern Ready Mix.
